**Agreement:** In accepting the opportunity to participate as a vendor in the San Jose Convention Center for the **Spirit of the Flame Challenge** on February 26-28, 2010, I do hereby accept the following listed conditions and limitations.

- 1) Use is limited to the San Jose Convention Center Parkside Hall.
- 2) Telephone, water, electrical and drain service will not be provided to the individual booths. Electrical service will be an additional charge.
- 3) All displays must be free standing. Nothing may attach to walls or columns of the convention center by any means at all.
- 4) **Set up hours:** Friday, February 26, 12:00 pm – 4 pm.
- 5) **Vendor hours:** Friday February 26, 4:30 pm – 10:00pm  
Saturday, February 27, 8:00 am – 10:00 pm.  
Sunday, February 28, 8:00 am – 9:00 pm.
- 6) **Tear down hours:** Sunday, February 28, after competition concludes.
- 7) **Signs:** Signs must be free standing. Recommended usage of easels. Signs should not block other vendor booths. Signs may attach to your table. Signs may not attach to the walls or columns of the SJCC
- 8) **Insurance:** It is the sole responsibility of the vendor to obtain insurance coverage on property brought onto the premises of the San Jose Convention Center. Vendor assumes full responsibility of items left in the booths.
- 9) **Food and Beverage:** Hospitality room provided by WVGBC for up to 2 associates.
- 10) **Payment:** Booth reservations are received with payment in advance. Booth locations will be assigned by Event Director.
- 11) **Cleaning:** Vendor responsible for cleaning the booth area and removal of bulk trash. If left unclean, removal fees will apply.
